Since the inception of the corporate form, the for-profit corporation existed primarily to increase shareholder wealth. Historically, the most common analysis applied to evaluate investments was based on generally accepted accounting standards, conventions and rules, also known as GAAP (Generally Accepted Accounting Principles).

While GAAP has its values and continues to be a core part of investing, an ESG strategy broadens the considerations that financial professionals may utilize in making investment decisions. Can fiduciaries use ESG investing strategies, and if so, how? How should attorneys general advise pension plans, universities and other governmental investing entities regarding the use or avoidance of ESG investing strategies? Does corporate leadership violate duties to shareholders if the corporation applies ESG or does ignoring ESG analyses compromise the basic principle of reducing risk?

State attorneys general can play an important part in fighting corruption. That role can include filing civil or criminal charges against corrupt officials, partnering with other enforcers on task forces, and opining about appropriate statutes to address corrupt behavior. At the same time, some states have limited criminal jurisdiction and may not have the resources or in-house expertise to handle complex, white-collar investigations. Moreover, as elected officials themselves, attorneys general may face arguments that enforcement actions are politically motivated. This panel addresses both the opportunities and challenges for attorneys general who do this crucial work, particularly given recent Supreme Court cases suggesting that federal law leaves much public corruption to the states to rectify.
