Many Attorneys General offices engage in advocacy and protection of abused and neglected children. Most have ICAC (Internet Crimes against Children) units. Some have positions dedicated to identifying and eradicating child human trafficking, the average age for which is 12–15 years. Most states have mandatory child abuse reporting laws. With all this expertise and focus, we simply must address this travesty of child exploitation. This session will focus on the many ways youth are vulnerable to being trafficked (sex trafficking, forced labor, domestic servitude, debt bondage, forced marriage, and more), and the trauma experienced by these especially vulnerable youth.
