2023 saw a troubling resurgence in ransomware and cyberattacks. According to a report commissioned by Apple, "70 percent more attacks were reported through September 2023 than in the first three quarters of 2022." And the FBI's 2023 Internet Crime Complaint Report found that government facilities were the third largest ransomware target. With an active cyber threatscape, and the evolution of artificial intelligence potentially supercharging attacks, the need to harden state attorney general office and state government systems and cybersecurity procedures has never been greater.
