**MASTER STIPULATION AND ORDER DISMISSING WITH PREJUDICE  
CLAIMS PURSUANT TO SUN SETTLEMENT AGREEMENT**

IT IS HEREBY STIPULATED AND AGREED, by and between the undersigned counsel of record for the Plaintiff Subdivisions identified in Appendix A (collectively, the “Dismissing Plaintiffs”) and Defendant Sun Pharmaceutical Industries, Inc. (“Sun”)<sup>1</sup> that, pursuant to the election of each Dismissing Plaintiff to participate in the Sun Settlement Agreement, dated April 4, 2025, as amended, and is binding on the Dismissing Plaintiffs and Sun, and which has an Effective Date of January 29, 2026, all claims of each Dismissing Plaintiff against any Sun entity, including any entity identified on the attached Appendix C, are hereby **DISMISSED WITH PREJUDICE**, with each party to bear its own costs. The Court shall retain jurisdiction with respect to the Sun Settlement Agreement to the extent provided under that Agreement.<sup>2</sup>
